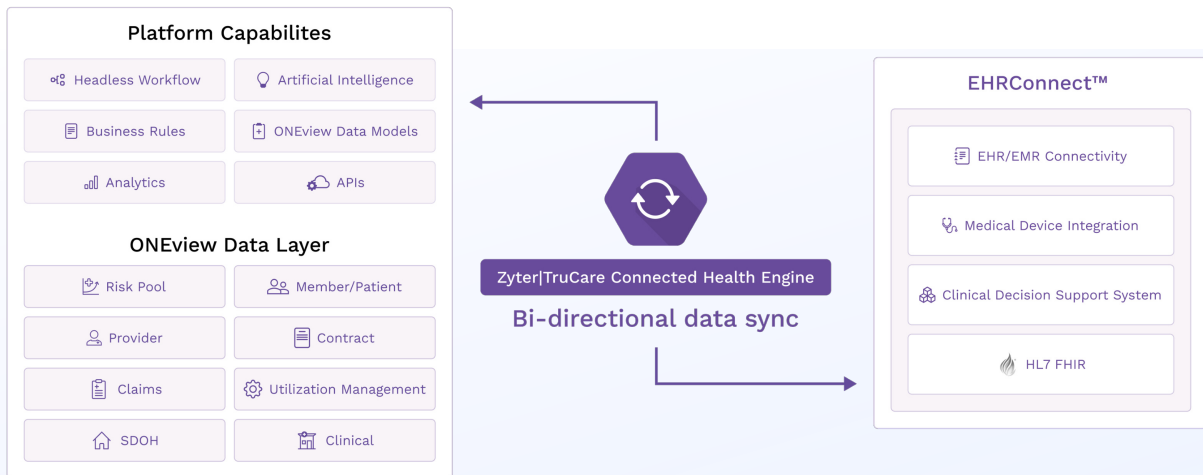

It allows providers and care teams to access holistic, real-time data to make informed decisions about the next-best action because ensuring interoperability among the many digital tools used to manage an individual's care is essential.



-  View the continuity of care documents (CCD) summarizing all clinical information for a patient.
-  Authorize users to access and update information in Zyter|TruCare records and harmonize them into their clinical workflows. Data is real-time and can drive user alerts, increasing adherence and compliance.
-  Submit care management requests from their EHR to be fulfilled in the Zyter|TruCare platform.
